## 1. Navigating the Future: Exploring AI in School Counseling Russ Sabella





# 2. One Conversation: It Can Change Your Life Deirdra Williams

**SPEAKER BIO:** Deirdra Williams is the Director of Programs and Advocacy for the American School Counselor Association (ASCA). Prior to joining the ASCA staff in 2021, she served high school students for over 20 years as a school counselor and Dean of Counseling and Student Services in one of the largest school districts in North Carolina. She is also a past Government Relations chair and as well as past President for her SCA.

Deirdra developed a passion for advocacy while serving as her SCA's Government Relations chair and President. Her advocacy work expands from local, to state to national work and now supporting advocacy efforts of state leaders. Deirdra also coordinates the Recognized ASCA Model Program (RAMP). She uses her own experience of earning RAMP, and providing trainings to school districts to further advocacy efforts by supporting school counselors seeking to earn RAMP for their school. Deirdra encourages use of the ASCA National Model for school counselor advocacy, especially at state and local levels.

All professionals wishing to better understand the law and how these can affect schools are invited to attend.

# 4. Engaging All Stakeholders To Build Student Success Nicole Fields

**ABOUT THIS SESSION:** This professional learning session offers a comprehensive and practical exploration of effective stakeholder engagement to support student success. Grounded in evidence-based practices, the session will guide participants through strategies for building trust and cultivating meaningful relationships with diverse stakeholder groups. Emphasis will be placed on fostering effective communication and collaboration, as well as implementing systems to sustain long-term engagement. Participants will leave with actionable tools and insights to enhance partnerships that drive positive outcomes for students.

SPEAKER BIO: Dr. Nicole M. Fields is the inaugural high school Professional School Counselor at Grace M. James Academy of Excellence within Jefferson County Public Schools. Fields is also an affiliate faculty member at the University of Louisville and an adjunct professor at Spalding University. With a passion for change agency, community engagement, and mental health wellness, Dr. Fields serves as a board member of the Mental Health Advisory Board for the Louisville Urban League. Previously, she has worked as the Community Engagement Coordinator on the Diversity, Equity, Inclusion, and Belonging Team for the Kentucky Department of Education, a Family Resource Youth Service Center Coordinator, and a Professional School Counselor at all three levels for Jefferson County Public Schools. Dr. Fields is the 2024 School Counselor of the Year for Jefferson County Public Schools. Additionally, she currently holds the position of Vice-President of Post-Secondary Education for the Kentucky School Counselor Association and is recognized as an emerging leader. Dr. Fields earned a Master's in Human Resource Training and Development from Webster University, a Master's in Education for School Counseling from Spalding University, and a Doctorate in Educational Leadership from the University of Louisville. Dr. Fields is also a member of Delta Sigma Theta Sorority, Incorporated. Dr. Fields married her college sweetheart, and they have three beautiful children.

# **Understanding Students Through Their Perspectives Tommie Mabry**

**SPEAKER BIO:** Dr. Tommie Mabry grew up in one of Jackson, MS roughest neighborhoods. He was suspended or expelled from several schools due to his behavior. Things started to change for Tommie when he joined an AAU basketball league that traveled around the world. He received a full basketball scholarship to Missouri State University-West Plains and later received a B.A. cum laude in Education from Tougaloo College and his M.A. in Child Development. After his undergraduate studies, Tommie was hired as a teacher by the same Jackson Public School District that had suspended and expelled him many times during elementary and secondary education. He went on to get a Doctorate Degree – an Executive Ph. D. from Jackson State University in 2020 where he majored in Urban Higher Education. Tommie now travels the world sharing his story to motivate and inspire others.



#### **Lieutenant Governor Jacqueline Coleman**

Lieutenant Governor Jacqueline Coleman is scheduled to appear

**SPEAKER BIO:** Jacqueline Coleman is the 58th Lieutenant Governor of Kentucky. She is a life-long Kentuckian, educator, basketball coach, writer and founder of a nonprofit. She is wife to Chris, mom to Evelynne, adopted mom to Emma, and a bonus mom to Will and Nate. Her family lives in Frankfort.



After graduating from Mercer County High School, Jacqueline attended Centre College, where she majored in history and secondary education and played on the basketball team. Basketball has always been part of Jacqueline's life and instilled values in her like attention to detail, discipline, and teamwork. Her grandfather, Jack Coleman, Sr., was the University of Louisville's first 1,000-point scorer, a hall-of-famer, and two-time NBA champion. Jacqueline earned her master's degree in political science from the University of Louisville and served on the women's basketball coaching staff. As a high school basketball coach, she appeared in the 2017 KHSAA Sweet 16 and was named regional coach of the year in 2015.

As the state's highest elected teacher, Jacqueline is a vocal and passionate advocate for public education. She believes education is the key to providing Kentuckians opportunities for transformational change that can create new cycles of success. She began her career as a high school civics teacher in her hometown at Burgin High School. Jacqueline also taught at East Jessamine High School and, most recently, served as an assistant principal at Nelson County High School. She is currently completing a doctorate in educational leadership at the University of Kentucky.

Her experience in Emerge Kentucky inspired her to found her own nonprofit, Lead Kentucky, in 2013. Lead Kentucky ensures Kentucky's college women are prepared, encouraged, and empowered to seek leadership positions on their campuses and later in their professional lives. Since its inception, Lead Kentucky has empowered students on more than a dozen college campuses.

Jacqueline remains focused on the challenges Kentucky families face. During her first term, through the Team Kentucky Student Mental Health Initiative, she worked with student leaders to secure more than \$40 million in federal funding to increase student mental health resources in schools across the commonwealth. In January 2020, she led the charge to waive the testing fee for adults earning their GED. Since then, more than 8,100 Kentuckians have earned a GED and changed the trajectory of their families' futures. She revived the Kentucky Commission on Women after its office was shuttered and funding was removed during the previous administration. As a rural Kentuckian, she aims to ensure Kentucky's booming economy reaches every zip code.
